

REQUIREMENTS FOR REGULATED MEMBER, PROVISIONAL REGISTRATION Specialty Practice Limited [CPSM General Regulation, s. 3.16]

The specialty practice limited class is intended to permit the registration of physicians who do not meet the certification requirement for full registration, but meet certain specified minimum standards and commit to work towards achieving the requirements for full registration within a specified time (5 years).

Eligibility in this class for those who require an assessment will be restricted to those who intend [to practice in a specialty that Council has determined is eligible for provisional \(specialty practice limited\) registration.](#)

Applicants must meet the academic requirement for registration (ie. a medical degree from a nationally approved faculty) and are given 5 years in which to obtain certification from the Royal College. As a result, additional requirements for initial registration are imposed in certain circumstances. Each requirement is followed immediately by particulars of the exemptions for that specific requirement.

CREDENTIALS:

1. Hold a medical degree from a nationally approved faculty of medicine or a Doctor of Osteopathic Medicine degree from a school in the U.S. accredited by the American Osteopathic Association Commission on Osteopathic College accreditation.
2. Establish that he or she meets one of the following criteria:
 - a. holds the qualifications to engage independently in the practice of medicine in a specialty field of practice in a jurisdiction outside Canada in which the applicant has trained AND has completed postgraduate clinical training in the intended field of practice that:
 - A. is approved by the Registrar;
 - B. took place in one or more health care facilities recognized by a national postgraduate training authority; and
 - C. was accredited by a national postgraduate training authority.
 - b. holds Royal College certification or be confirmed by the Royal College as eligible for Royal College certification;
 - c. holds certification from a Member Board or be confirmed by a Member Board as eligible for board certification;
 - d. holds certification from the Collège des Médecins du Québec;
3. Have satisfactorily completed an approved specialty practice assessment and have entered into a satisfactory arrangement with a practice mentor, unless he or she is exempt from the assessment and mentor requirements because he or she
 - a. establishes, to the satisfaction of the Registrar, that he or she:
 - A. was previously registered in good standing (as either a conditional or s. 64 registrant in a specialty field under the former Act, or as a provisional specialty limited or s. 181 in a specialty field) and practised in Manitoba but has subsequently ceased to hold registration,
 - B. has either satisfactorily completed a specialty practice assessment in the specialty field of practice in which the applicant wishes to practise or was exempt from this requirement while he or she was previously registered in Manitoba, and
 - C. has the training and experience necessary to competently engage in professional practice within the intended specialty field of practice; or
 - b. holds Royal College certification or provides written confirmation from the Royal College that he or she is eligible for certification, unless the eligibility has been or will be obtained through the practice eligibility route
- c. holds certification from the Collège des Médecins du Québec; or
- d. holds Member Board certification and has satisfactorily completed a postgraduate training program accredited by the Accreditation Council for Graduate Medical Education (USA).

ADDITIONAL REQUIREMENTS:

1. If applicable, establish that he or she has engaged in the professional practice that he or she intends to practise in Manitoba within the approved time period.
2. If applicable, provide a satisfactory description of the continuing professional development activities that the applicant was required to complete as a condition of authorization to practise medicine in any jurisdiction in Canada in the three years immediately preceding the application and how the applicant met these requirements.
3. Be issued a certificate from the Minister stating that the physician is required to provide medical services in a specified geographical area or practice setting.
4. Have entered into an arrangement satisfactory to the college with a practice supervisor.
